

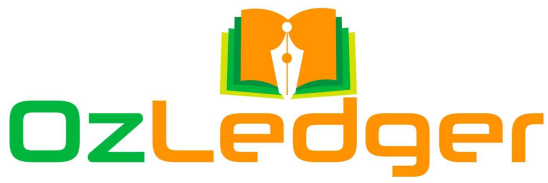

INDEPENDENT AUDITOR'S REVIEW REPORT

To the members of Anbaalayam Incorporated

Report on the Financial Report

We have reviewed the accompanying financial report of Anbaalayam Incorporated, which comprises the statement of financial position as at 30 June 2020, the statement of comprehensive income for the year ended on that date, notes comprising a summary of significant accounting policies and other explanatory information, and the directors' declaration.

NOTES TO THE FINANCIAL STATEMENTS

1. Entity

Anbaalayam Incorporated, INC 9891333, (Anbaalayam Australia) is a not-for profit-incorporated association functioning primarily in Sydney, New South Wales.

In order to provide operational and administrative effectiveness to Anbaalayam Australia, Anbaalayam (Guarantee) Ltd (Anbaalayam Sri Lanka), registration number - GL2475, was established in Sri Lanka on 27 February 2018. A bank account was also opened at Hatton National Bank (HNB) - Wellawatte branch. During the financial year, Anbaalayam Australia paid a grant of \$80,921.10 (2019: \$44,078.90) to Anbaalayam Sri Lanka and funds were distributed from there for various purposes like natural disaster, child sponsorship, livelihood projects, educational support projects and sponsor a meal contributions.

Various donations, child sponsorship contributions and livelihood support contributions were also directly deposited by well wishers into our Anbaalayam Sri Lanka's bank account.

2. Basis of Preparation of Financial Statements

This financial report is a special purpose financial report prepared on cash basis. It is prepared in compliance with the recognition and measurement aspects of the Australian Accounting Standards. The financial report is prepared for the use of the membership and for the purpose of providing the Executive Committee with financial information relevant to the function and obligations of Anbaalayam Australia.

3. Summary of Significant Accounting Policies

a. Revenue is recognised on cash basis.

4. Sponsor a child:

Anbaalayam was built around the idea of supporting children with their educational needs, and currently support 110 children with their educational needs. 25 of these children are supported at \$25, and 49 children are supported at \$50 monthly. The rest are supported with different amounts as required by the child's educational needs.

82 of these children are supported by sponsors and the rest are supported by funds from Anbaalayam.

5. Sponsor a meal:

This is also another small project we do to support some of the orphanages with a day's meal. Sponsors pay to celebrate any of their family events.

6. Cultural Event – Ilam Thendral 2020 (Night of compassion)

Ilam Thendral is our major annual fundraising event. Approximately 700 of our donors and supporters attend this event every year. This event also provides a platform for our local community to showcase their diverse talents. All our members and volunteers come together on this day and make it a huge success.

Due to the restrictions imposed in light of COVID-19, Ilam Thendral 2020 which was scheduled for 4th April had to be cancelled.

Our regular patrons, donors and sponsors generously donated to this unfortunate loss of revenue by contributing their purchased event tickets as general donations and partially financed this year's activities.
